Courses and Birds Ducks and/or pheasants to be used in all stakes.

Welcome to the 85th GRCA National Specialty Field Trial. A special thanks to the Missouri Department of Conservation and the staff at the August A. Busch Memorial Conservation Area for the use of the facilities and grounds. We also thank the judges, workers and club members and many other volunteers that make this event possible. We also thank the many members of other local retriever clubs whose dedication and help we rely on to help in so many ways. Thank you!

Please help us cooperate with the Department of Conservation by NOT exercising dogs within 100 yards of any building, by restricting parking to only one side of roadwaysm, and by not driving on grass or in fields unless instructed by marshals.

Per Section 5.26 of the Wildlife Code of the State of Missouri: The sponsoring organization shall issue identification bearing the field trial permit number to all persons without a valid hunting permit who enter dogs in a trial. The permit number for this trial will be posted at the field trial headquarters.

PLEASE BE AWARE that there will also be a "Goldens Only" Hunt Test at this year's National and WC/WCX Tests following this field trial.

Drawing The electronic draw will take place at 12:01 am Central Time on 14 August 2025 and will be posted online available for viewing upon final approval by the Golden Retriever Club of America.

Refunds Prior to the close of the trial, you must contact Entry Express for refunds. Full refunds of entry fees for dogs withdrawn after the closing date, in accordance with Chapter 14, Section 2 of the Field Trial Regulations, will require notification of the field trial secretary prior to the starting time of the stake and appropriate veterinary certification no later than September 29, 2025. Full refunds for bitches in season and injured dogs (with veterinary certificate). A \$40 fee for all other scratches received before the start of the stake. No refunds for scratches after the start of the stake.

Puppy Stakes will be held on Thursday, September 18. These are non-regular stakes for puppies 6-9 months of age and 9-12 months of age on the last day of the trial. Bumpers may be used in lieu of birds.
