Drawing

The electronic draw will take place at 08/14/2025 12:01 am Central Time and will be posted online available for viewing upon final approval by the Golden Retriever Club of America.

Refunds

Bitches in season are not allowed on the test grounds. Prior to closing, all scratches and refunds will be handled by Entry Express. To remove an entry before the close, handers should go online to the event entered, go to the View Entries page and simply click on the "Remove" link shown beside the dog(s) entered and wish to remove, completing the information requested. A scratch fee will be assessed by Entry Express of any scratches handled by Entry Express.

After closing, scratches and refunds will be handled by the Hunt Test Secretary. Full refunds will be given for bitches in season and dogs who are ill/injured or deceased. Refunds will be given provided the Test Secretary is notified of scratches prior to the start time of the stake entered. A veterinarian's certificate or confirmation of an injury/illness is required. The note must be received by the Test Secretary within seven (7) days after completion of the event in order to receive a refund. Send the note to the Test Secretary by US Mail to the address listed or by email to the Test Secretary. Refunds for hardship or extenuating circumstances are at the sole discretion of the test committee. A \$25.00 processing fee will be retained for all refunds to cover entry administration.

No refunds for no shows.

Running Order

The running order will be posted on Entry Express after the closing date. Whenever possible, dogs will be run in the order of the draw as fairly and expeditiously as possible at the discretion of the judges.

Food

There will be no food on site but there are several places to eat within 10 miles of the grounds. Please bring food and water for you and your dog(s).
